Appendix IX: Texas A&M University Smoke-Free Rules

~~(Revised: 1993)~~

~~The compelling scientific findings, as summarized by the United States surgeon general and the Environment Protection Agency, indicate that the simple separation of buildings into “smoking” and “nonsmoking” sections does not eliminate the unequivocal health risks that result from environmental tobacco smoke. In light of the health hazards associated with tobacco smoke for smokers and nonsmokers alike, Texas A&M University has adopted the following smoke-free rules:~~

~~I. Guidelines~~

- ~~A. All buildings and vehicles, regardless of location, that are owned or leased under the administrative purview of the president of Texas A&M University will be entirely smoke free. This smoke free rules will apply to all indoor air space, including foyers, entryways and classrooms, individual faculty and administrative offices.~~
- ~~B. All indoor air space of university owned athletic facilities will be smoke free. Outdoor public seating areas in athletic arenas and theaters will be smoke free.~~
- ~~C. University owned and leased housing (apartments, residence halls) and eating areas (dining halls, cafeterias, food courts, snack bars, Faculty Club) will be smoke free.~~

~~II. Implementation~~

- ~~A. The appropriate unit heads have the following responsibilities with respect to these rules:
 - ~~1. Assuring that the rules are communicated to everyone who occupies space in the facility.~~
 - ~~2. Implementing the rules and guidelines and ensuring that appropriate notice is provided.~~~~
- ~~B. The vice president for administration shall see that appropriate signs are displayed throughout the campus and in university vehicles.~~
- ~~C. Implementation of the smoke free rules will be preceded by smoking cessation clinics sponsored by the Health Promotion Program, Human Resources Department. These programs will include informational and education activities regarding tobacco and cigarette smoking, as well as smoking cessation programs for members of the university community who want to use this opportunity to quit smoking.~~

~~III. Enforcement~~

~~These rules rely on the thoughtfulness, consideration and cooperation of smokers and nonsmokers for their success. It is the responsibility of all members of the campus community to observe the provisions of these guidelines.~~

Appendix IX: Texas A&M University Smoke-Free Rules

(Revised: 2014)

Texas A&M University has a vital interest in maintaining a healthy and safe environment for its students, faculty, staff and visitors. This rule identifies university property where smoking and tobacco use is restricted.

Definitions

Smoking shall have the meaning specified in System Policy 34.05 Smoking.

Tobacco means all forms of tobacco products including but not limited to cigarettes, cigars, pipes, water pipes (hookah), bidis, kreteks, electronic cigarettes, smokeless tobacco, snuff and chewing tobacco.

University Property means property located in the State of Texas that is owned, operated, leased, occupied or under the administrative control of the President of Texas A&M University. For purposes of this rule, this includes but is not limited to all grounds, buildings and structures, sidewalks, parking lots, walkways, and all vehicles owned, leased or rented by Texas A&M University.

I. GUIDELINES

- A. Housing and athletic facilities. Texas A&M University owned and leased housing (apartments, residence halls), and all indoor air space of University owned athletic facilities and outdoor public seating areas in athletic arenas will be smoke-free.
- B. Eating areas. Eating areas (dining halls, cafeterias, food courts, snack bars, University Club) will be smoke-free and tobacco-free.
- C. Buildings and Vehicles. All other buildings, entrances to buildings, and vehicles, owned or leased under the administrative purview of the President of Texas A&M University will be entirely smoke-free and tobacco-free. This rule will apply to all indoor air space including foyers, entryways and classrooms, individual faculty and administrative offices, and sidewalks, parking lots, walkways, and attached parking structures immediately adjacent to all such buildings and structures.
- D. On approval of the President, the smoking and tobacco restrictions described in this rule may be expanded to include all University Property in order to establish a tobacco-free campus.

II. RESPONSIBILITIES

- A. It is the responsibility of all members of the campus community, including visitors, to observe these requirements. This rule relies on the thoughtfulness, consideration and cooperation of smokers and

tobacco-users for its success. Those violating this rule should be reminded of this rule and asked to comply.

- B. **Department heads or others with purview over facilities shall ensure that the rule is communicated to everyone who occupies space in the facility.**
- C. **The Vice President for Administration will provide signage upon request and Transportation Services will provide notice for University vehicles.**
- D. **Violations of this rule may result in corrective action as prescribed by system policies and regulation and university rules and procedures. Visitors refusing to comply may be asked to leave campus.**
