On August 15, 2022, the Curriculum Committee approved adding a new grade of High Pass to the required clinical clerkship courses (IMED 800, MFCM 800, MPED 800, MPSY 800, MRAD 800, OBGY 800 and SURG 800). Implementation would be slated for April 2024 with the Class of 2026.

The new proposal is to add High Pass to the existing grading system:

• Honors: 4 grade points per semester hour


• High Pass: 3.5 grade points per semester hour


Pass: 3 grade points per semester hour

• Fail: 0 grade points per semester hour

Fail/Pass: 1 grade point per semester hour


According to the <u>Association of American Medical College</u>, in 2020-2021 only 25 out of 155 medical schools use our existing Honors/Pass/Fail grading system compared to 81 using the Honors/High Pass/Pass/Fail grading system. The School of Medicine wants to align our grading system with national standards.





The School of Medicine recently adjusted the grading system for our pre-clerkship phase (semesters 1, 2, and 3) to satisfactory/unsatisfactory, removing the GPA attached to the final grade. This change also reflects national standards of a binary grading system in the pre-clerkship phase of the curriculum.

If we do not adjust our clerkship phase (semesters 4, 5, and 6) to the national standards, the students' GPA will look lower than their actual performance outcomes. Adding the High Pass (3.5 grade points) will add more differentiation to the clerkship grading system and make students more competitive in their residency application process. Adding the High Pass will also allow students to meet our prescribed graduating with honors criteria (3.50 GPA).



Reinstate U/S grade - Justification

In summer of 2022, the Curriculum Committee at the School of Medicine determined to use a different, but approved and existing grade mode for the preclerkship phase of the curriculum. We have continuously used the S and U grade modes for the fourth year and several of our courses as well.

Due to the competitive nature of residency application and match, medical schools are expected to rank students. Although systems vary across medical schools, most schools only include some or all of their required courses in the GPA and ranking system. The Curriculum Committee decided to move the preclinical required curriculum to an S/U grade mode in order alleviate stress and anxiety, increase student well-being, and help students focus on learning core material versus focusing on points and grades.

S/U grading during preclinical curriculum is a national trend at medical schools and has shown to have a positive impact on medical student well-being. Including preclinical grades in GPA calculation and ranking and using a tiered grading system that includes honors has proven to increase burnout, stress and drop-out rates.

The School of Medicine had a U/S grade mode to show that a student remediated a course (versus retaking the full course again), and the student handbook has U/S listed as a grade mode. During the move from the Texas A&M Health Science Center to Texas A&M University in or around 2013, the U/S grade was not transferred over to the system with the Registrar. This oversight was not caught until recently with the change in grading for our preclinical curriculum. Although used sparingly in the past, the need and use of the U/S grade will be more significant. For any course using the satisfactory/unsatisfactory grade mode, a "U" will be recorded as a "U/S" once the course has been remediated.

The Curriculum Committee hopes these changes will reduce stress and anxiety while increasing student success. In addition, it will allow the school to communicate transparently to graduate medical education programs about students applying to their programs.

Rule Number and Section Number: 10.5.2 (including 10.5.2.1, 10.5.2.3, 10.5.2.5)

Title of the Rule: Doctor of Medicine Degree Program (College-School of Medicine)

Suggested Changes:

10. Grading

10.5.2 Doctor of Medicine Degree Program (College School of Medicine)

10.5.2.1 In addition to A, B, C, D, S, U, I and W grades (see 10.3 above), medical students may be assigned the following letter grades:

H: Honors, 4 grade points per semester hour

HP: High Pass, 3.5 grade points per semester hour

P: Pass, 3 grade points per semester hour

F: Fail, 0 grade points per semester hour

F/P: Failed course, remediated, 1 grade point per semester hour

U/S: Failed course, remediated. S, U, U/S grades are not used to calculate the student's cumulative GPA.

10.5.2.2 Grades of Q are not assigned to medical courses.

10.5.2.3 Only grades of H, HP, and P, and S are passing grades. Grades of F must be resolved by remediating or repeating the courses and achieving a grade of F/P. Grades of U must be resolved by remediating or repeating the courses and achieving a grade of U/S.

10.5.2.4 When successfully repeating a course, the original F or F/P grade and the grade in the repeated course are indicated on the transcript and are used to calculate the student's cumulative GPA.

10.5.2.5 A temporary grade of incomplete (I) for a course/clerkship at the end of a course/clerkship usually indicates that the student has completed the course with the exception of some portion of work. The instructor shall give an incomplete grade when the deficiency is due to an authorized absence or other cause beyond the control of the student or when all but a single component of the course/clerkship has been completed. The grade will be changed to a P/F/HP/H when the course requirements are complete.

10.5.2.6 Grading processes specific to the College-School of Medicine are further explained in the College-School of Medicine Student Handbook.
