Dr. Harrell updated the committee on the status of pending rule revisions for **Rule 20 Academic Misconduct** and **Rule 14.2 Degree Requirements,** Approved by Faculty Senate on 1/13/25 and sent to President, waiting for memo from President's office to update the website

Dr. Harrell updated **Rule 7.2.2.6 Attendance** and **Rule 14.16.4 Degree Requirements**, both needed additional discussion with other groups of people, rules were sent back to submitters.

## Rule 10.4 – Passing grades for graduate students are A,B,C, and S

**Discussion:** Trent Smith: said there was discussion in the Grad School, not opposed to adding language for clarification but has issues with some verbiage in the red-line version,

Rob Rahm: concurred that wordsmithing needs to be done and gave different scenarios that could occur that the red-line version doesn't address,

Trent Smith: suggested getting input from Registrar's office,

Bridgette Ingram: possibly a chart is a more effective means of communicating.

Any week in which there are regularly scheduled classes, is considered a week. The week of fall break is counted as a week of classes. The week of spring break is not. Is there a potential rule change that needs to happen or different language on the academic calendar? Challenging to change language on academic calendar due to the way it's coded: website limits, number of line items, etc.
